

Bentleyville Borough Minutes  
Reorganization Meeting - Monday, January 06, 2020  
6:30 PM at the Bentleyville Municipal Complex

Re-elected Council Members Roy Larimer (4 years), Gary Damich (4 years), Wayne Hite (4) years and Tax Collector Jillian Blackburn Pernel (1 year) were all sworn in by Mayor Tom Brown.


