Executive Session - Personnel Issues

Old Business:

A motion to approve the January 06, 2020 Reorganization meeting minutes was made by Wayne, seconded by Gary. The motion carried.

New Business:

Stan asked how garbage collection was going. There have been several missed pickups in the past month, but the Office Manager at County Hauling is trying to correct the issues. Tim explained the problems are with the small truck.
