Business from the Floor:

Brittany Javorsky of 121 Penn Avenue is concerned about the parking and traffic pattern of Nikerson's Nursery Nook on Johnston Road. Kerry Krider of HMT said this was advertised in the paper, approved by the Zoning Hearing Board and all residents within 300 feet of the business were notified with certified letters.

Josh McCaslin of 847 Main Street purchased the old laundromat across from the Borough. He said it is zoned as B1 and says it can be used as mixed use, meaning you can have apartments as long as they are not on the first floor. He asked Council for permission to turn the upstairs into two apartments. Kerry said he would need to fill out an application for a special exception and there would be a zoning hearing board meeting. Wayne asked where the parking would be and Josh said he is going to talk to the Bentleyville Tavern and see if they would rent some of their parking lot to him.

Jennifer Cario of 704 Main Street runs Bentworth Blessings, a program that meets any needs of at risk children in the school district. She wants to look into job training, parenting training and help children get to college. Jennifer and her husband own the Carlton Diner in town. She wants to work on the economy and bring more businesses into Bentleyville.

Old Business:

A motion to approve the February 04, 2020 meeting minutes was made by Wayne, seconded by Gary. The motion carried.

A discussion to establish criteria for the volunteer service credit program is needed. Council will meet with Ron Sicchitano Jr. to discuss.

Stan and Tammy met with Dennis on February 24, 2020 and signed all the documents to purchase the Eagles. Dennis said we are waiting for the IRS paperwork showing the federal liens have been satisfied. Stan would like to have a work session on Monday, March 16, 2020 at 6:30pm to discuss the Eagles and ideas for its use. After that, Stan would like to approach some residents in the community for their ideas as well.

Tim was at the American Legion recently and the request was made by the Legion to relocate the Veteran's Banners to the Borough. Tim suggested we store the banners at the Eagles.

Council members and Borough employees need to complete the NIMS 100 and NIMS 700 courses. Ron Sicchitano volunteered to come in to review and give handouts on the courses.

Bentworth Area Youth Soccer Association requested the use of Richardson Park, including the concession stand, beginning the week of 3/09/2020 through 6/07/2020. A motion to approve the use of the park was made by Wayne, seconded by Shannon. The motion carried.

A Planning Commission meeting will be held on Monday, March 23, 2020 at 7:00pm for Ross Self Storage. A motion was made to advertise the meeting by Gary, seconded by Tim. The motion carried.

Stan would like to transfer money from the Local Share and Impact Fee accounts to the General Fund account. Tim will check into this.
