A motion was made by Gary, seconded by Bob to add to the agenda the request for the Federal Aviation Administration to park a vehicle in the Borough parking lot. The motion carried. Shane Miller asked to park a government owned vehicle in the Borough parking lot. Council asked Tammy to contact Solicitor Makel about this for insurance reasons. Gary suggested a reserved parking sign be put in place for this vehicle, at their expense. A motion was made by Stan, seconded by Tom to allow the vehicle to be parked in the Borough lot contingent on Solicitor Makel's recommendation.
