<ol> <li>That a tax be and the same is hereby levied upon all property within the corporate limits of the Borough of Bentleyville, Washington County, Pennsylvania subject to taxation for Borough purposes for the fiscal year 2017 in the amount of 2.524 mills (.02524) on each assessed valuation.</li> </ol>	
<ol> <li>(A) That Ordinance Number 183 of 1 367 of 1983, imposing a per capita tax of five dollars at the same rate of five dollars (\$5.00) for the fiscal year</li> </ol>	
(B) That Ordinance Number 213 of 1966, imposing a tax of one percent (1%) on all transfers of realty within the Borough of Bentleyville is hereby re-enacted and continued at the same rate for the fiscal year 2017.	
(C) That Ordinance Number 218 of 1967, imposing a tax of one half of one percent (1/2%) upon the earned income persons residing and/or working within the Borough of Bentleyville is hereby re-enacted and continued at the same rate for the fiscal year 2017.	
(D) That Ordinance Number 300 of 1974, imposing a twenty (20) mil tax upon the occupations of persons within the Borough of Bentleyville is hereby re-enacted and continued at the same rate for the fiscal year 2017.	
(E) That Ordinance Number 566 of 2014, together with its amendments, imposing a Local Services Tax of fifty two dollars (\$52.00) is hereby enacted for the fiscal year 2017.
