## Bentleyville Borough Minutes Reorganization Meeting - Monday, January 03, 2022 6:30 PM at the Bentleyville Municipal Complex

The elected Mayor, Timothy Jansante (4 years), was sworn in by District Judge Curtis Thompson.

Re-elected council member Stanley Glowaski (4 years), and newly elected council members, Thomas Brown (4 years), Timothy Miller (4 years), Joseph Pigeon (4 years), along with re-elected Tax Collector Jillian Pernell (4 years) were all sworn in by Mayor Tim Jansante.

The meeting was called to order by Mayor Tim Jansante with the recitation of the Pledge of Allegiance. Roll was called with the following council members present: Stan Glowaski, Tom Brown, Tim Jansante, Roy Larimer, Gary Damich, Tim Miller, Joe Pigeon and Dennis Makel.
